1. General Terms and Conditions-

- 1.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.
- 1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable
- 1.3 All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

2. Buyer Added Bid Specific Terms and Conditions-

2.1 Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} - \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2.3 Buyer Added Bid Specific ATC:

3. Certificate/Declaration required :

- a) MSE : The bidder who is the manufacturer of the offered item may submit valid documents for claiming them as eligible MSEs.
- b) Land Border Sharing Certificate [GFR 144 (xi)] – Certificate/declaration reg. Land Border Sharing is compulsory. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
- c) OEM Certificate (*applicable for manufacturer only*) : In case the Bidder is the OEM, a declaration to this effect must be attached along with the offer. This certificate with valid date must contain Name, Designation, Email Address and Mobile Phone Number of the authorized signatory along with the address of the office.
- d) MAF Certificate (*applicable for dealer only*) : In case the Bidder is offering products on behalf of the OEM, a proper Manufacturer's Authorization Certificate (MAF) with valid date must be attached with the quotation and it should contain Name, Designation, Email Address and Mobile Phone Number of the authorized signatory along with the address of the office.
- e) Any other certificate required by the user (if any)
