

संस्थान के विज्ञापन संख्या R&C/600/2025, रिक्ति कोड: 6002501 से 6002513 के संदर्भ में, स्क्रीनिंग कमेटी के पहले चरण का परिणाम 10.06.2025 को प्रकाशित किया गया था। पहले चरण के दौरान, समिति ने कुछ उम्मीदवारों को, अनुशंसित उम्मीदवारों के साथ, उनके आवेदनों में किए गए दावों के समर्थन में दस्तावेजों के कमी प्रस्तुत करने की शर्त पर, अनंतिम रूप से अनुशंसित किया गया। तदनुसार, संस्थान ने अधिसूचना संख्या प्रशासन 1(4)/2018/Tech दिनांक 10.06.2025 के माध्यम से, अनंतिम रूप से अनुशंसित उम्मीदवारों को 30.06.2025 की विस्तारित समय सीमा तक आवश्यक कमी के दस्तावेज प्रस्तुत करने की सलाह दी और साथ ही संबंधित उम्मीदवारों से अभ्यावेदन भी मांगे गए / With reference to the Institute's Advertisement No. R&C/600/2025 under Vacancy Codes: 6002501 to 6002513, the result of the first phase of the Screening Committee was published on 10.06.2025. During the first phase, the Committee provisionally recommended certain candidates, along with recommended candidates—subject to the submission of shortfall documents in support of the claims made in their applications. Accordingly, the Institute, vide Notification no. Admn. 1(4)/2018/Tech dated 10.06.2025, advised the provisionally recommended candidates to submit the requisite shortfall documents by the extended deadline of 30.06.2025 as well as sought representations from any concerned candidates.

- 2. उपरोक्त के मद्देनजर, विधिवत गठित स्क्रीनिंग समिति ने विज्ञापन में उल्लिखित प्रावधानों और दिनांक 10.06.2025 की अधिसूचना के तहत अपनाई गई पात्रता/शॉर्टिलिस्टिंग मानदंडों के अनुसार, अनंतिम रूप से अनुशंसित उम्मीदवारों द्वारा प्रस्तुत सभी कमी वाले दस्तावेजों, साथ ही निर्धारित तिथि अर्थात 30.06.2025 के भीतर प्राप्त अभ्यावेदनों की जांच की है / In view of the above, a duly constituted Screening Committee has scrutinized all the shortfall documents submitted by the provisionally recommended candidates, as well as the representations received within the stipulated date, i.e., 30.06.2025, in accordance with the provisions mentioned in the advertisement and the eligibility/shortlisting criteria adopted vide notification dated 10.06.2025.

All other candidates will not be considered for further evaluation.

- 6. ट्रेड टेस्ट के लिए उपर्युक्त पद हेतु उम्मीदवारों की शॉर्टिलिस्टिंग अनंतिम है और कार्यालय द्वारा आवश्यकतानुसार सभी प्रासंगिक मूल दस्तावेजों के सत्यापन और मूल प्रमाण पत्र प्रस्तुत करने के अधीन है / The shortlisting of candidates for the aforementioned post for the **Trade Test** is **provisional** and subject to verification of all relevant original documents and production of original certificates, as and when required by the office.
