EMPANELMENT OF ADVERTISING AGENCIES FOR CSIR-IICB

1. परिचय / INTRODUCTION

The Institute was established in 1935 as the first non-official Centre in India for biomedical research and was included within the aegis of CSIR in 1956. CSIR-IICB today is engaged in research on diseases of national importance and biological problems of global interest, employing sophisticated state-of-the-art technology in keeping with the rapid and unprecedented momentum that life science research has gained globally over the last 50 years. The scientific staff has expertise in a variety of areas including chemistry, biochemistry, cell biology, molecular biology, neurobiology and immunology which promotes productive interdisciplinary interaction.

2. कार्य का दायरा / SCOPE OF WORK

The brief scope of work of the empanelled agencies includes the following. Any other work related to corporate publicity, media campaign, etc. will also form part of the scope as decided from time to time.

- The agency shall release advertisements in print or any other media as decided by CSIR-IICB.
- The agency shall assist CSIR-IICB in selecting appropriate methods and media of advertisement, preparing drawings / blocks, undertaking research, and liaising with newspapers/publications on behalf of CSIR-IICB.
- Raw data/ Material/information will be provided by CSIR-IICB, and agencies will be required to prepare artwork. Designing, typesetting, artwork preparation of block/matrices, and art pulls for release of advertisements shall be undertaken by the agency free of cost, irrespective of advertisement size or number of newspapers
- The agency shall ensure optimum utilization of space in all tender advertisements avoiding wastage and ensuring cost-effectiveness.
- The agency shall be required to submit the artwork for approval.
- The agency will not be entitled for payment related to designs, artwork, or for translation of material from one language to another (English/any Indian language).

3. पैनल में सम्मिलन हेतु योग्यता मानदंड / QUALIFYING CRITERIA FOR EMPANELMENT

The minimum qualifying requirements are stipulated below. An Agency not meeting any one of the following criteria would be summarily rejected and would not be considered for further evaluation:

- a. The agency should have a minimum average annual turnover of 1 crore from business related to Media/Advertising/Publicity during the last three consecutive financial years, i.e. 2024-25, 2023-24 and 2022-23.
- b. The agency should have full Indian Newspaper Society (INS) accreditation for the last three consecutive years, and the accreditation should be valid as on the last date of submission of the proposal.

- c. The agency should have a registered office in Kolkata at least for the last **05 (FIVE)** years.
- d. The agency should have the ability to provide multi-lingual content (at least in Bengali, Hindi and English).
- e. The agency should have a minimum of five (05) years of experience in advertisement/publicity related work, out of which it must have rendered services to at least two (02) Central Government / State Government / PSU / Autonomous Bodies or similar institutions.
- f. The agency should have at least 05 (FIVE) full-time staff in their Kolkata office.
- g. The agency should not have been blacklisted by any Central/State Government/PSU/Autonomous Body or similar institutions during the last five (05) years from the last date of submission of the proposal.
- h. The agency shall submit audited Financial Statements, including Balance Sheet and Profit & Loss Account, for the last three consecutive financial years, duly certified by a Chartered Accountant and Bank Solvency Certificate amounting to ₹10,00,000/- (Rupees Ten Lakh only).

Note: In case of the discovery at any stage about false/misleading/suppressed information and submission of fake/tampered documents in support of the above or suppression of facts, the proposal shall be rejected and empanelment, if already done with CSIR-IICB, shall be cancelled after giving opportunity of representation. In such a case, CSIR-IICB reserves the right to blacklist such agency for a period upto **THREE YEARS**.

4. बयाना धनराशि (अर्नेस्ट मनी डिपॉजिट – ईएमडी) / EARNEST MONEY DEPOSIT (EMD)

The Earnest Money of **₹30,000/-** (Rupees Thirty Thousand Only) as Demand Draft or Pay Order of a scheduled bank and drawn in favour of Director, CSIR-Indian Institute of Chemical Biology, Kolkata should accompany the Proposal. Scanned copy of payment of EMD to be uploaded by the Proposer at CPPP website <https://etenders.gov.in/eprocure/app>. Proposal received without scanned copy of Demand Draft or Pay Order of EMD fees will be invalid and summarily rejected. All bidders shall have to submit the original Demand Draft or Pay Order of EMD and copies of all other relevant documents which to be uploaded themselves during tender in support of credentials etc., alongwith a forwarding letter within five days from the date of Technical bid opening to the Works and Services Section (Room No -50), CSIR-IICB, Jadavpur, Kolkata. Technical Bid of a bidder without submission of original Demand Draft or Pay Order for EMD within the stipulated time will be invalid and summarily rejected.

NB: Amendment in EMD clause As per 'Rule 170 of GFR 2017 (Pg. No.49)' and 'SOP No 5/1, SI No.6 (Pg. No.34) under Subhead " Contract Management" of CPWD Works Manual 2019' and 'Micro and Small Enterprises (MSEs) Order 2012 under section 11 of MSME Act, 2006 and Gazette notification on 26th March 2012' "The MSME firms registered in NSIC under PP policy are exempted from payment of EMD for supply of goods and services only". No other relaxation shall be allowed. EMD exemption to MSME (NSIC) registered firm will be accepted as per guidelines of Govt. of India. Bid Security Declaration and MSME certificate is (Ref. FORM-III) required in this case.

5. कार्य निष्पादन सुरक्षा जमा (पीएसडी) / PERFORMANCE SECURITY DEPOSIT (PSD)

In addition, the empanelled agency shall be required to deposit an amount of **₹45,000/- (Rupees Forty-Five Thousand only)** as Performance Security Deposit (PSD) within the period prescribed in the letter to be issued prior to empanelment. The Performance Security Deposit shall be refunded without any interest upon expiry of the empanelment period, subject to satisfactory performance and clearance of all dues. The PSD may be forfeited, in full or in part,

in case of breach of terms and conditions, non-performance, or unsatisfactory performance, as decided by CSIR-IICB.

6. प्रस्ताव प्रस्तुत करने की प्रक्रिया / SUBMISSION OF PROPOSAL

- The proposals shall be submitted through e-tendering portal only (<https://etenders.gov.in>).
- It is mandatory for all the agencies to have Class-3 Digital Signature Certificate (with both Signing and Encryption certificate) (in the name of person who will sign the bid) from any of the licensed certifying agency (“CA”) [List of licensed CAs can be seen from the link www.cca.gov.in] to participate in e-tendering of CSIR-IICB.
- To participate in the submission of the proposal for empanelment as advertising agency with CSIR-IICB, it is mandatory for the agencies to get them registered with e-tendering portal <https://etenders.gov.in> to have user ID and password. If the agency has already registered with the e-tendering portal and validity of registration has not expired, then such agency does not require fresh registration.

7. पैनल में सम्मिलन हेतु प्रस्तावों का उद्घाटन / OPENING OF PROPOSALS FOR EMPANELMENT

Opening of proposals shall be done online by a Committee of CSIR-IICB officers at 15:00 Hrs 18th February 2026 in CSIR-IICB, Kolkata office, in presence of the representatives of the agencies who wish to attend.

8. प्रस्तावों का मूल्यांकन / EVALUATION OF PROPOSALS

The proposals will be evaluated by a Committee, constituted for this. Agencies will be selected based on marks secured on evaluation of proposals.

- Stage – I. All the proposals will be scrutinized to assess their eligibility based on the minimum qualifying criteria as per clause 3 of Section II of this Request For Proposal (RFP). The proposals not meeting the qualifying requirement will be summarily rejected and not considered for further evaluation.
- Stage – II. All the eligible proposals meeting the qualifying requirement will be evaluated based on the Experience, Experience with Central/State Government/PSU/Autonomous Body or Similar Institutions and Turnover (Average) as per the points indicated in Annexure I (Evaluation Criteria).

On the basis of combined marks obtained out of 100, the ranking will be done. A decision will be then taken for empanelment of top ranking agencies depending on overall evaluation & suitability.

9. पैनल की अवधि / DURATION OF EMPANELMENT

The empanelment will normally be for a period of **THREE** years. However, CSIR-IICB reserves the right to terminate the empanelment of any agency at any time or to go into fresh empanelment before three years, depending upon circumstances. **The empanelment does not, in any way, guarantee any minimum business and allocation of work to the agency.**

10. कार्य आवंटन की विधि / METHOD OF JOB ALLOCATIONS

The empanelled agencies will be required to service CSIR-IICB for creatives and releases. In the event of specific launch of an Advertisement, CSIR-IICB reserves the right to contact any / all empanelled agencies to develop / submit creatives. CSIR-IICB reserves the right to distribute the selected creatives so developed either to Central Bureau of Communication or amongst one or more agencies for further release of the same to the Advertisement. Any avoidance or denial shall be treated as a serious failure based on which termination of empanelment may be carried out.

All advertisements shall be released strictly on a rotational and/or competitive bidding basis, or through such other mode as may be determined by the Committee and/or the Competent Authority from time to time.

Bill for advertisement releases should invariably be supported by copies of the bills from newspapers rate cards, CBC/DAVP rate cards, original tear sheets and other relevant bills in duplicate. Payment will be made in each case after verifying these documents.

The agencies will not be paid for translation of material in English to Hindi, English to Bengali or to any other Indian Languages, if required. In case of publication of corrigendum due to wrong translation/ missing/ wrong text by the agency, the cost of re-publication will be borne by the advertising agency itself.

For all advertisements including tender notices in newspapers, No charges will be paid for design and supply of art pulls/photocopies.

The agency will not be paid for creative and design in case the Advertisement Campaign is launched through them. However, in case the advertisement Campaign is launched through DAVP/ Central Bureau of Communication, the agency will be paid lump sum amount for the selected creative advertisement designs depending upon creativity of the job executed. In all the cases, the Copyright of creative will be with CSIR-IICB.

Empanelled Agencies would be expected to respond to CSIR-IICB and attend all meetings/briefings called for by CSIR-IICB and will have to deliver the job allotted within the stipulated time frame. All empanelled agencies are expected to participate in competitive bidding when asked to do so by CSIR-IICB. CSIR-IICB reserves the right to terminate the empanelment in case of non-compliance of this clause.

CSIR-IICB reserves the right to assign work to a non-empanelled agency only under exceptional circumstances, with recorded justification and prior approval of the Competent Authority, in the interest of the Institute.

11. भुगतान की विधि / MODE OF PAYMENT

- No payment shall be made in advance; all payments shall be made on submission of bills.
- Necessary taxes as applicable will be deducted from the bill.
- Payments, subject to Tax Deduction at Source shall be processed within 60 days of the submission of the complete documents
- The bill must be raised for the complete release of order. Bills not accompanied with tear sheets or paper cutting of the newspaper and CBC/DAVP rate card will not be considered for payment.
- The rates shall be strictly as per the CBC/DAVP rate card.

- If the rates are enhanced by CBC/DAVP after payment of original bills, no supplementary bill will be accepted, and the Agency will have to clarify this to the publication of their own, and no liability will be accepted on this account by the Institute.

12. आवधिक समीक्षा / PERIODIC REVIEW

The performance of the empanelled agencies will be subject to continuous review. Agencies showing poor performance and service will be warned and serious action, including termination may follow. At any stage, the decision of CSIR-IICB will not be open to question and will be treated as final. CSIR-IICB reserves the right to terminate the services of any agency at any time without assigning reason whatsoever.

Incomplete proposals, conditional proposals are liable to be rejected summarily.
