If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**2. Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

### 3. Buyer Added Bid Specific ATC

1. **Payment Terms:** As per GeM Payment Terms subject to acceptance of Performance Security.
2. **EMD:** The bidder has to submit an EMD along with the bid for 02 (Two) percent value of the estimated cost. Exemption as per GOI allowed.
3. **Performance Security:** The vendor has to submit a Performance Security equivalent to 5 (Five) percent of the purchase order value before release of payment. The performance security should remain valid for a period of 26 (Twenty-Six) months from the date of successful installation and commission of the supplied equipment.
4. **Delivery Period:** Delivery should be completed in full within a period of 30 (Thirty) days or as per the GeM prescribed Delivery Terms for the item from the date of Purchase Order. Liquidated Damage clause will be imposed in the event of non-completion of delivery within the stipulated time.
5. **Delivery Location: SI. Nos. 1-8 to be delivered to CSIR, Jadavpur Campus, Kolkata and SI. N os. 9-11 to be delivered to CSIR-IICB, Salt Lake Campus, Kolkata.**
6. **Installation and commissioning:** To be installed at site by the supplier within the delivery period. The supplier shall also have to impart necessary training for effective operation and maintenance of the goods.
7. **Warranty:** Two (02) years for all items. Please note that, notwithstanding any warranty period mentioned in the detailed specifications, the applicable warranty for all items shall be treated as two (02) years only.
8. **Catalogue/Leaflet/Brochure:** Catalogue / Leaflet / Brochure may be asked from the bidder to justify the specification/feature of their offered equipment.
9. **Successful bidder will be required to visit this institute and take final measurement prior to commencement of the work.**
10. **The bidders should quote for all items as provided in the tender specification.**

### 11. Certificate/Declaration required:

- I. **Make In India:** The Bidder must furnish a "Make In India" declaration/Certificate issued by the Manufacturer of the offered product. Such Declaration should indicate about the class/category (Class I- or II) in which the offered product/s fall as well as the percentage of Local Input of the offered product and the detailed address of the place (manufacturing unit) where the input is being added. The Declaration/Certificate should have full name and designation of the signatory along with his/her email ID, direct phone number, office address. MII declaration, if not issued by the manufacturer or incomplete in nature, shall not be considered as an eligible MII Docu

ment and in such event the bid shall be treated as non-responsive.

**II.** **MSE:** The bidder who is the manufacturer of the offered item may submit valid documents for claiming them as eligible MSEs.

**III.** **Land Border Sharing Certificate [GFR 144 (xi)]:** Certificate/declaration reg. Land Border Sharing is compulsory. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this, failing which the bid shall be treated as non-responsive. Any false declaration and non-compliance of this guidelines, if found at a later stage, would be a ground for immediate termination of the contract and further legal action in accordance with the laws.

**IV.** **OEM Certificate (applicable for manufacturer only):** In case the Bidder is the OEM, a declaration to this effect must be attached along with the offer. This certificate with valid date must contain Name, Designation, Email Address and Mobile Phone Number of the authorized signatory along with the address of the office.

**V.** **MAF Certificate (applicable for dealer only):** In case the Bidder is offering products on behalf of the OEM, a Tender/Bid specific Manufacturer's Authorization Certificate (MAF) issued by the manufacturer in favour of the bidder is required to be attached along with the quotation. The certificate should contain Name, Designation, Email Address and Mobile Phone Number of the authorized signatory along with the address of the office. MAF Certificate, if not bid specific or not covering these points, shall not be considered as an eligible MAF document and in such event the bid shall be treated as non-responsive.

**VI.** **CSIR Guidelines on Disposal of Rejected Goods Procured on GeM-** No payment shall be made for rejected goods. After intimation of the rejection / part rejection by CSIR-IICB, the Seller shall be liable to remove /lift back rejected Goods within 10days of communication of rejection of GeM or otherwise without any extra charge / cost to CSIR-IICB failing which suitable ground rent / warehousing charges would be payable by the Seller to CSIR-IICB. If the seller fails to remove / lift back such rejected Goods within 45 days period, CSIR-IICB shall have the right to dispose off such rejected goods at the risk and cost of the seller in terms of CSIR guidelines for disposal of rejected goods procured on GeM.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस नियिदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
