  - (i) Category of Bidder :- Class-I (Minimum 50% local content of their offered item)

- 2) Evaluation and comparison of the technically qualified firms with applicable price preferences under Make In India policy will be done as per the provisions mentioned in the referred order of GOI for selecting the firm for placement of purchase order.
